Who is Covered?

All registered members of USA Rugby, Including athletes, coaches, referees, Executive administrators.

Sanctioned Activities:

While participating in USA Rugby scheduled, sponsored or supervised activities.

Coverage Summary:

This policy provides accidental death, dismemberment and medical coverage to eligible USA Rugby persons. Medical expense coverage is excess coverage, meaning it is secondary coverage to any other health insurance. If the participant has other coverage, claims must first be filed with that insurance company.

Medical expenses must be incurred within 30 days of the date of accident

Accidental Death & Specific Loss:

Principal Sum: \$10,000

Benefit Period: Loss within 52 weeks of Injury

Coinsurance:

70%

The following riders are attached to and made a part of this policy:

 Heat related problems including heat exhaustion, heat prostration, and heat stroke, overuse or repetitive motion injuries/ injuries/symptoms including bursitis, while participating in a Covered Sports **Exclusions** – Loss caused by or resulting from suicide or any attempt at suicide or intentionally self-inflicted injury or any attempt at intentionally self-inflected injury, while sane.

Sickness, disease or infections of any kind, except bacterial infections due to an accident cut or wound, botulism, or ptomaine poisoning. Declared or undeclared war. Additional exclusions are subject to any other terms and conditions listed in the policy – available upon request
