

Chairman's Report

eason 2010 will be remembered as a groundbreaking year in the history of the New South Wales Rugby Union and professional Rugby in Australia.

In what was the most significant change in off-field operations since the sport went professional 15 years ago, last year saw the professional game in NSW separate from community Rugby and move under its own administration. 2010 was the first year of trading for NSW Waratahs Limited, a distinctly constituted and governed entity which is directly responsible for the operations of professional Rugby in this state.

The new structure allows the Board and staff of NSW Waratahs Ltd to use their expertise to concentrate solely on the professional game, with a view to generating increased revenue which will be invested back into the sport at all levels.

Similarly, the new structure allows the Board and staff of the NSW Rugby Union to exclusively focus on the health of the game at the grassroots level with community-based programs and competition management.

This organisational structure is not new in professional sport, however it is a new concept in Rugby and NSW Waratahs Ltd are the pioneers. With the NSWRU Board made up of specialists in all the aspects of grassroots Rugby, the NSW Waratahs Ltd Board consists of some of the best minds in business, sponsorship, marketing and media, and as a Board we are striving to make this new era an extremely successful one. Importantly, the new structure does not

lose touch with the grassroots of the game. In fact, the structure ensures that the relationship between professional and grassroots Rugby in NSW will always be inextricably linked.

The NSWRU has granted NSW Waratahs Ltd a license to conduct operations under the 'Waratahs' brand. This means the intellectual property associated with the historic and iconic brand remains with the NSWRU. NSW Waratahs Ltd will pay an annual license fee to NSWRU for the use of the 'Waratahs' brand, with these funds enabling NSWRU to administer and conduct community Rugby programs and competitions across the state.

In the first year of operation, NSW Waratahs Ltd has reported a loss of \$201,939. There is no doubt that separation of the two entities required some transition, however there are clearly a number of areas in which the organisation needs to focus on in order to make significant inroads to the balance sheet.

The business has reacted accordingly by implementing change which will not only deliver significant cost savings, but also enable the organisation to operate in a far more streamline fashion.

Falling membership in recent years is an area which required addressing and a remodelling of packages after the 2010 season has already seen figures back on the rise. New sponsorship properties and an increased emphasis on corporate hospitality are opening up new avenues, and the expertise of the NSW Waratahs Ltd directors will be called upon to drive this change. There are also opportunities within our licensing program to be explored and we will continue to look at ways to keep driving strong home crowds in a congested Sydney sporting

Importantly, our existing sponsorship base is extremely strong and is led by our naming rights sponsor. HSBC has been emblazoned across the NSW Waratahs jersey since 2002 and the brands are now definitively linked. We are proud to have been there right from the start and look forward to being a continuing part of HSBC's association with Rugby through to 2013 and beyond.

To Mazda, our sleeve sponsors, to IBM, who hold the naming rights to HSBC Waratahs headquarters - the IBM Centre - and to all of our other valued partners, I thank you for your continued support of the team as the Super Rugby competition enters a new era from 2011. You are very much a part of every success we achieve.

The HSBC Waratahs enjoyed another

successful year, recording qualifying for the semi-finals for the fourth time in six years. The task against the Stormers in Cape Town proved too tough, however the team finished the season with their heads held high as the top Australian team.

Along the way the HSBC Waratahs defeated all other Australian teams and recorded an undefeated season at home. Phil Waugh became the state's most capped player and captain, while Drew Mitchell topped the Super Rugby tryscorers list.

Importantly, the team continues to lead the way in Australian sport with one of the highest levels of participation in education or employment outside of Rugby. Over 80% of players within the Super Rugby and HSBC Junior Waratahs squad partake in study or work either part-time or full time. This is a key focus for the organisation and we work strongly with the Rugby Union Players' Association to achieve this mark.

Similarly, one of the central themes in the culture of the organisation is community and corporate responsibility, and the team's enthusiasm to get involved is central to this. The players and coaches made hundreds of community visits throughout the year and lent their time to numerous charities. The organisation's principal charity in 2010 was again The Spastic Centre (now, the Cerebral Palsy Alliance), with the charity jersey auction and proceeds from the sale of programs and caps throughout the year raising more than \$94,000 for the charity.

I would like to thank outgoing CEO Jim L'Estrange for his service to Rugby in this state and know he will remain a friend of the HSBC Waratahs. I also welcome new CEO Jason Allen who brings strong experience in business and sports administration. Jason is building a great administrative team around him which is complemented by the best coaches and team management in Australian

Thank you to the inaugural Board of NSW Waratahs Ltd who have seen the transition process through to its completion. The hard work really starts now as we look to take the HSBC Waratahs and professional Rugby in NSW into its most successful era both on and off the field.

Finally, thank you to all the members and supporters who continue to get behind the team every week throughout the Super Rugby season. There are exciting times ahead and we look forward to you being a big part

Commercial Operations

COMMERCIAL & PARTNERSHIPS

2010 presented challenges to the HSBC Waratahs and the game of Rugby as a while. With that said, there were some successes that have allowed the launch of the Super Rugby season in 2011 to be seamless and successful.

The HSBC Waratahs clash with the Brumbies at ANZ Stadium drew a crowd of 40,271; the largest home crowd since 2002 and the second largest crowd of the professional era.

This match, along with a crowd of more than 31,000 for the final match of the regular season against the Hurricanes, pushed the average crowd for the season to 24,206. This was an increase of 1.6% from 2009 and was coupled by an 1.9% increase in television ratings for fixtures involving HSBC Waratahs.

Once again the HSBC Waratahs were the most-watched Australian team in the Super 14 competition, drawing a cumulative international audience of 8.35 million viewers.

An areas of striking improvement in 2010 was retail sales. With a renewed association with apparel supplier Canterbury, HSBC Waratahs merchandise sales increased by 260% from 2009. The most popular item of apparel was again the home jersey, with over 8000 units sold.

The value of the HSBC Waratahs brand was exemplified in 2010 with an 8.5% increase in sponsorship revenue, coupled with a recommitment from naming rights sponsor HSBC to take the partnership past a decade and through to 2013.

Not surprisingly, according to Repucom data

HSBC was the best performing and mostvisible sponsor across all Australian Super Rugby teams.

Corporate Hospitality is an area which has good scope for improvement with the introduction of attractive new packages a key element to carry forward in seasons to come. One area in which corporate hospitality received a great boost in 2010 was the Chairman's Club with average attendance increasing by almost 80%. The HSBC Waratahs Chairman's Club has quickly become one of the premier match day experiences across any sport in Sydney with quality entertainment and great service providing a high-class sporting experience.

The HSBC Waratahs' commitment to the wider community is no better highlighted than in the annual charity match, and in 2010 a uniquely-designed jersey was introduced for the first time. The jersey was worn in the final-round fixture against the Hurricanes in front of the biggest crowd at the Sydney Football Stadium for the year. After the game the players' jerseys went to the highest bidder in an online auction, with the proceeds from the auction as well as match program and charity cap sales throughout 2010 raising \$94,839 for the Spastic Centre, now known as the Cerebral Palsy Alliance.

As mentioned earlier, HSBC signed on again as the naming rights sponsor of the HSBC Waratahs, and their support celebrates ten seasons in 2011. HSBC, sleeve sponsors Mazda and IBM - naming rights sponsors of HSBC Waratahs headquarters, the IBM Centre - provide fantastic support for the team and the entire organisation and their long-term commitment reflects the health of the relationship.

While a full list of sponsors can be found on page 2, it is important to acknowledge the new partners which joined in 2010: Canterbury, Coca-Cola Amatil, Air Pacific, MJ Bale, Nando's, Power Living, IDS Displays, The Week magazine, Douglas Fabian Productions and Helping Hand Group.

MARKETING

To create successes in a touch market, changes were made to the Marketing strategy, reworking the advertising mix, increasing the digital focus.

We embraced our business solutions partner, IBM, to assist in the development of the new HSBC Waratahs and NSW Rugby Union websites. The website was split into two sites in September 2010, ensuring distinctive brand identities and creating a clearer navigation process for those using the sites.

For the 2010 marketing campaign, the main messages were 'It's our Time' and 'Proud to be Tah'd'. As well as the tactical tag lines, we increased the players' profiles by using their names in the campaign to make a more personal and closer association with supporters.

A more cautious approach to saw the marketing spend reduced in 2010 with a more cohesive approach developed with media partners and sponsors. The introduction of a TVC and working with new partners (including Fox Sports and MTV) on production as well as communication enabled the reduced spend to still deliver increased attendances at home games.

Another success story was the introduction of the Waratahs HQ concept. Engaging supporters for away matches and post-game, the five venues were well-received and in 2011 will feature 15 venues across both metropolitan and regional areas.

The game day experience was also ramped up with supporter engagement within the stadium and precinct areas. Half time became a celebration of Rugby and its grassroots stakeholders. At the conclusion of the 2010 season the event presentation supplier partnership went to tender and a new partner was appointed to increase the value of entertainment delivered to our fans.

Possibly the biggest shift in the face of the organisation is the increasing focus on the digital medium. Our marketing strategy going forward will continue to have strong dedication to this area in which direct contact with fans and members can be far more effective.

Commercial Operations

The HSBC Waratahs Facebook site more than doubled its fan base in the four-month period of the Super 14 tournament from 4050 to 9993. By the end of the year the number was closer to 15,000 and is by far the most popular of all the Super Rugby

Utilising the three key social media networks of Facebook, Twitter and YouTube, the HSBC Waratahs are for the first time entering the digital space with a dedicated marketing focus. This will continue to be developed as a crucial element in the overall media plan and will become the key driver behind the fan engagement strategy of the organisation.

The media department continued to work with all forms of media to create consistent opportunities for coverage when both home and abroad. A strong working relationship with the Sydney Rugby media has been extended to all regions in which the competition is based, with the HSBC Waratahs always offering and providing media opportunities when on the road.

Again a key aspect to the HSBC Waratahs media exposure has been the ability to provide vision and imagery to the major media outlets when on the road in New Zealand and South Africa. Vision and interview packages are provided to Fox

Sports to distribute to TV networks, audio grabs are sent directly to radio networks and photos are provided to print press; the ability to do this assists greatly in gaining coverage which would otherwise be impossible.

MEMBERSHIPS

Membership is an area in which there is great scope for improvement, and while there is a lot of ground to make up, 2010 saw the introduction of initiatives which are bringing the organisation closer to its most loyal supporters.

A new initiative for members was introduced with the "Tah Trolley" option. The success of memberships is paramount so creating higher value products for members was imperative. Tah Trolley was success with over 30% of members taking the opportunity to purchase the HSBC Waratahs jersey for half the recommended retail price.

Following the 2010 season a thorough review of memberships was conducted. The importance of member servicing and acquisition is paramount and a more flexible suite of packages was introduced for season 2011.

Corporate Hospitality remained flat from an overall sales perspective, but the new initiative of the Chairman's club grew with a 17% increase.

MEDIA

In 2010 the strong performance of the team resulted in an equally strong performance in the media with a 16% increase in print media coverage.

In turn, the shift in articles which appeared in a positive light was up 51% compared to 2009. When combined with the articles which were neutral in tone, this accounted for 74% of total media which was consistent with 2009.

In a report compiled by Repucom International, HSBC Waratahs major partners generated RBA+ exposure value of \$2.046m which was up more than 5% on the previous year.

eason 2010 was a mixed one for the HSBC Waratahs on many fronts. Some of the best performances seen by any side during the competition were coupled with a relatively small number of disappointing defeats, and ended with the team falling just one match shy of the final.

While a number of changes took place in squad and management from 2008 to 2009, the off-field team was unchanged in 2010 which created a stable environment for everyone in the organisation. From the football and physical performance coaches to the medical unit, team management, analysis and media, all of the team staff continued to work well together and there will be minimal change moving forward with only assistant coach Scott Wisemantel moving on in 2011.

The squad had a number of new faces in 2010 with Wallabies Berrick Barnes and Drew Mitchell, Gordon flanker Chris Alcock, former All Black Sosene Anesi, ex-Emerging Springbok Hendrik Roodt, and Kiwi-born ex-Leinster lock Cam Jowitt all joining the organisation in the Super 14 squad for the first time. Ben Coridas and Damien Fitzpatrick were both elevated from positions in the HSBC Junior Waratahs, while Kane Douglas, Locky McCaffrey and Pat McCutcheon were both promoted to the Super squad mid-season. Josh Holmes returned from the Brumbies, while former HSBC Junior Waratah Rory Sidey was back after a season with Newport-Gwent Dragons in Wales.

Such a transition in the playing group requires time to come together, however once combinations were settled the HSBC Waratahs played some of the best football in the competition and finished the year with their best attacking record since the inception of Super Rugby in 1996.

A hot pre-season led to a series of three trial matches, two of which continued the team's commitment to take the HSBC Waratahs to the people of NSW. The opening trial against Queensland in Lismore blooded a number of youngsters, while more experienced players returned for a big win over the Fiji Warriors in Orange. The final trial resulted in a tight win against the Brumbies in Canberra which took the team into round one with some good momentum.

The opening match of the season saw one of the gutsiest victories by a NSW team in some time, coming back from a 28-18 deficit inside the last ten minutes to record a 30-28 win. Wycliff Palu scored under the posts

in the dying moments before and Daniel Halangahu converted on the siren to retain the Templeton Cup.

The match was the first in NSW colours for Sosene Anesi, Berrick Barnes, Kane Douglas, Cam Jowitt, Drew Mitchell and Rory Sidey. The match was not without drama however, with Cam Jowitt suffering an ankle injury that would eventually rule him out of football for the rest of the year, while Dean Mumm suffered a two match suspension.

The team left immediately for South Africa for a two-match tour. Hendrik Roodt made his NSW debut in a loss to the Stormers in which Daniel Halangahu earned his 50th state cap and Will Caldwell surpassed Tom Bowman as the HSBC Waratahs' most-capped lock in Super Rugby. The following week the team suffered another disappointing loss against the Bulls however it would go on to be remembered as one of the matches of the season.

The first home game for the year resulted in a 25-21 victory over the Sharks, however the following week was met with an avalanche of

Phil Waugh led the team out for the 41st time in his 119th NSW appearance to pass Chris Whitaker as both the state's mostcapped player and most-capped captain. They were not the only records set on the night as the team went on to record a 73-12 victory over the Lions. The result was the HSBC Waratahs' highest score in Super Rugby and biggest winning margin in Super Rugby, attained from the most number of tries (11)

and conversions (9) the team has scored in a tournament match. Drew Mitchell's four tries and Berrick Barnes' nine conversions were also a team Super Rugby record.

The team earned its second win against an Australian opponent in round six with a 14-10 victory over the Western Force in Perth, and returned to Sydney to score a 39-32 win over the Blues in Auckland. That match saw Phil Waugh bring up the most appearances

as NSW captain in Super Rugby (41) and the most victories as a NSW captain (26), however an injury forced him to miss the following game.

His replacement Chris Alcock brought up his state debut against the Cheetahs in round eight along with Locky McCaffrey. The 40-17 victory was another night of milestones at the SFS in which Al Baxter marked his 100th Super Rugby appearance with his first ever try for NSW. Dean Mumm became the state's 14th captain in the history of the tournament while Lachie Turner passed Tatafu Polota-Nau as the youngest player to reach 50 NSW caps at 22 years and 327 days. The victory was the team's fifth in a row which equalled the mark achieved five times in Super Rugby.

A new record could not be set however, with the HSBC Waratahs going down in a bonus point loss to the Crusaders in Christchurch. The match was also marred by a seasonending knee injury to the team's players' player for the past two years, Wycliff Palu.

Coming out of the bye week, the semi-finals equation started to become clearer and it was forecast the team would most likely require three wins in the last four matches to qualify. A 19-12 win against the Brumbies in front of more than 40,000 fans at ANZ Stadium got the team off on the right foot in a result which ensured the squad maintained a perfect season against all other Australian teams.

Pat McCutcheon debuted the following

Friday under dreadful conditions in Invercargill however it was the only bright part of the night with the team going down 26-10 to the Highlanders.

A week preparing in Christchurch proved great preparation for the final away game of the regular season with the team notching a 46-19 victory over the Chiefs in Hamilton, with Dean Mumm bringing up his 50th Super Rugby cap along the way.

The final match of the season was a virtual quarter-final with the victory of the HSBC Waratahs-Hurricanes clash assured of a place in the semis. Aiming for a perfect season at home, the HSBC Waratahs scored a stirring 32-16 victory with Drew Mitchell grabbing a double to take his season tally to a tournament-leading nine tries, while Kurtley Beale also scored two as he overtook Lachie Turner as the youngest player to reach 50 NSW caps (21y 128d).

After awaiting the results of other matches the following night, the team flew to South Africa to prepare to face the Stormers at Newlands. The team prepared well in Durban before the clash in Cape Town in front of a capacity crowd, however the Stormers were too strong on the night.

Upon returning to Sydney, Tatafu Polota-Nau was awarded the Matthew Burke Cup as the players' player. Phil Waugh was named Best Forward while Drew Mitchell capped his first year in sky blue with the Best Back award. Chris Hickey was also named Australian Super 14 Coach of the Year for the second season in a row.

Later in the year Tatafu Polota-Nau was the recipient of the HSBC Waratah Medal for on and off-field excellence while Kane Douglas picked up the Chris Whitaker Award for HSBC Junior Waratah of the Year.

While the result was just short of our goal, there were many positives to take out of a year which involved a sizeable transition amongst the playing roster. Equalling the HSBC Waratahs' longest tournament winning streak and winning every game at home went a long way to helping the team qualify for the semi-finals.


My thanks go to not only the squad but also the off-field team who ensured the team was in the best shape to have a successful season. The coaching team of Chris Hickey, Scott Wisemantel and Michael Foley were more than ably backed up by a team of specialists and assistants including Anthony Wakeling and Matt Burke, along with HSBC Junior Waratahs coaches Joe Barakat and Scott Bowen who guided the next generation to a strong season in the 'A' program.

The strength and conditioning program achieved some big records this season under physical performance manager Peter McDonald and new S&C coach Tom Tombleson while team doctor Sharron Flahive and physio Keiran Cleary kept the players on the field. My personal thanks must also go to assistant manager Nick Verhelst and team operations coordinator Jasmin Murphy.

Season 2011 will bring a number of new challenges in a hallmark year for the Super Rugby tournament. Competition expansion brings with it the opportunity to host more home games, play Australian teams more often and in turn raise the profile of the game in Australia.

The new competition format will reward the top-ranked team from each country with an automatic finals berth, and Australia's leading side for five of the past six years, the HSBC Waratahs will again be striving to lift the trophy for the first time.

ROUND 1 QUEENSLAND REDS V HSBC WARATAHS Saturday 13 February 2010 - Lang Park, Brisbane QLD.

The HSBC Waratahs opened season 2010 with a nail biter, claiming a 30-28 victory over the Queensland Reds at Lang Park in their first match of the 2010 Super 14 season.

The result could not have come in more exciting fashion, with Daniel Halangahu converting a last gasp Wycliff Palu after the siren to keep the Templeton Cup in New South Wales. It was the sixth time in a row that NSW defeated Queensland in a Super Rugby match and edged the Templeton Cup ledger in their favour for the first time (NSW 6, Queensland 5 since its inception in 2000).

ROUND 2 STORMERS V HSBC WARATAHS Saturday 20 February 2010 - Newlands, Cape Town RSA.

The HSBC Waratahs suffered their first defeat in South Africa since 2008 with a 27-6 loss to the Stormers at Newlands in Round 2.

The Stormers scored a try either side of half-time to turn the momentum their way, and followed it up with a third midway through the half to seal the victory.

During the match Daniel Halangahu came on from the bench to play his 50th match for the state, Will Caldwell became the most-capped NSW second rower in the history of Super Rugby and Phil Waugh surpassed Matt Burke as the second most-capped Waratah of all-time.

The defending champions proved too strong in the second half, coming from nine points down at the break to score their thirdstraight bonus point victory.

The Tahs looked set for at least two bonus points trailing by three with just minutes left on the clock and in attacking position, however the Bulls were able to turn the tables and score a late try to win by ten.







NSW Waratahs Limited was incorporated on 17 December 2009. The director's present their first report on the consolidated entity of NSW Waratahs Limited since incorporation to 31 December 2010.

2. Principal activities

The principal continuing activities of the Company during the course of the year ended 31 December 2010 were the business operations and management of a professional rugby union team. There were no significant changes in the nature of the activities of the Company during the year.

3. Operating and financial review

The operating loss for the year for the Company amounted to \$201,939.

The continuing viability of the Company and its ability to continue as a going concern and meet its commitments as they fall due are dependent upon the Company being successful in:

- a) receiving the continuing support of its members and the constituent bodies;
- b) achieving sufficient future cash flows to enable its obligations to be met; and
- c) success of the Waratahs in retaining and attracting new membership, sponsorship and other revenues associated with participation in Super Rugby competitions.

The Board is committed to continuous monitoring of these factors and any impacts on the future projected cash flows. The Board is also committed to a long term strategy to effectively manage and maintain a sustainable working capital balance.

Significant changes in state of affairs

2010 was the first year of trading for NSW Waratahs Ltd "WL". The creation of WL was to form a separately constituted and governed body, charged with the sole responsibility for administering all aspects of professional rugby in NSW. The voting members of WL, and two of six directors, were appointed by New South Wales Rugby Union Ltd "NSWRU" and accordingly the two legal entities are under common control. NSWRU has issued a licence to WL to conduct all the activities of administering professional rugby in NSW under the 'Waratahs' brand. The ownership of intellectual property in the 'Waratahs' remains vested with NSWRU. As a result, all contracts, agreements and other relationships pertaining to the operating of the Waratahs professional rugby business have been assigned to WL under licence. In addition, any assets and liabilities pertaining to the operation of the Waratahs at 1 January 2010 have been transferred to WL and are accounted for in accordance with the principles of predecessor accounting, which is applicable for entities under common control. Given the common control of the two legal entities, the assignment of the Waratahs activities was non-arms length and no consideration was paid or is payable.

Except for the matters above, there were no other significant changes in the state of affairs of the Company during the financial

4. Limited by guarantee

The Company is a company limited by guarantee. In the event of the Company being wound up each member is liable to contribute to the debts of the Company incurred whilst they were a member or within one year from them ceasing to be a member, or for the purpose of adjusting the rights of the contributors amongst themselves, such amount as may be required not exceeding \$10.

5. Proceedings on behalf of the company

No proceedings have been brought or intervened in on behalf of the company with leave of the Court under section 237 of the Corporations Act 2001.

1. Reporting entity

The financial report of NSW Waratahs Ltd ("the Company") has been drawn up as a special purpose financial report for distribution to the members and for the purpose of fulfilling the requirements of the Corporations Act 2001. In the opinion of the directors, the Company is not

The Company is a company limited by guarantee, incorporated and domiciled in Australia. The address of the Company's registered office and principal place of business is Gold Members Car Park, SFS, Driver Avenue, Moore Park, NSW 2000.

2. Basis of preparation

(a) Statement of compliance

In the directors' opinion, the company is not a reporting entity because there are no users dependent on general purpose financial reports.

This is a special purpose financial report that has been prepared for the sole purpose of complying with the Corporations Act 2001 requirements to prepare and distribute a financial report to the members and must not be used for any other purpose. The directors have determined that the accounting policies adopted are appropriate to meet the needs of the members.

The financial report has been prepared in accordance with the recognition and measurement principles of Australian Accounting Standards and other mandatory professional requirements in Australia. It contains only those disclosures considered necessary by the directors to meet the needs of the members.

The financial report of NSW Waratahs Ltd for the year ended 31 December 2010 was authorised for issue in accordance with a resolution of the directors on 5 April 2011 and covers NSW Waratahs Ltd as an individual entity as required by the Corporations Act 2001.

NSW Waratahs Limited is the parent and ultimate parent entity of the group.

(b) Basis of measurement

The financial statements have been prepared on the historical cost basis. The concept of accruals accounting has been adopted in preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

(c) Functional and presentation currency

These financial statements are presented in Australian dollars, which is the Company's functional currency.

(d) Use of estimates and judgements

The preparation of financial statements requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised and in any future periods affected.

The continuing viability of the Company and its ability to continue as a going concern and meet its debts and commitments as they fall due are dependent upon the Company being successful in:

- receiving the continuing support of its members and sponsors;
- (ii) achieving sufficient future cash flows to enable its obligations to be met; and
- (iii) success of the Waratahs in retaining and attracting new membership, sponsorship and other revenues associated with participation in Super Rugby competitions.

The Board is committed to continuous monitoring of these factors and any impacts on the future projected cash flows. The Board is also committed to a long term strategy to effectively manage and maintain a sustainable working capital balance.

3. Significant accounting policies

The accounting policies set out below have been applied consistently to all periods presented in these financial statements.

(a) Cash and cash equivalents

For cash flow statement presentation purposes, cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities on the balance sheet.

(b) Trade receivables

Trade receivables are recognised initially at fair value and subsequently measured at amortised cost, less provision for doubtful debts. Trade receivables are due for settlement no more than 30 days from the date of recognition.

Collectability of trade receivables is reviewed on an ongoing basis. Debts which are known to be uncollectible are written off. A provision for

doubtful receivables is established when there is objective evidence that the Company will not be able to collect all amounts due according to the original terms of receivables. The amount of the provision is the difference between the asset's carrying amount and the present value of estimated future cash flows, discounted at the original effective interest rate. The amount of the provision is recognised in the income statement.

(c) Property, plant and equipment

(i) Recognition and measurement

Items of property, plant and equipment are measured at cost less accumulated depreciation and accumulated impairment losses except for owner occupied office building.

When parts of an item of property, plant and equipment have different useful lives, they are accounted for as separate items of property, plant and equipment.

Gains and losses on disposal of an item of property, plant and equipment are determined by comparing the proceeds from disposal with the carrying amount of property, plant and equipment and are recognised net within "other income" in profit or loss.

Depreciation is recognised in profit or loss on a straight line basis over the estimated useful lives of each part of an item of property, plant and equipment. Land is not depreciated.

The estimated useful lives for the Company are:

• Team and office equipment

4 years

• Computer and IT equipment

4 vears

Depreciation methods, useful lives and residual values are reviewed at each reporting date.

(d) Impairment of assets

At each reporting date the entity assesses whether there is any indication that individual assets are impaired. Where impairment indicators exist, recoverable amount is determined and impairment losses are recognised in the income statement where the asset's carrying value exceeds its recoverable amount. Recoverable amount is the higher of an asset's fair value less costs to sell and value in use. For the purpose of assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset.

Where it is not possible to estimate recoverable amount for an individual asset, recoverable amount is determined for the cash-generating unit to which the asset belongs.

(e) Employee benefits

(i) Defined contribution plans

A defined contribution plan is a post-employment benefit plan under which an entity pays fixed contributions into a separate entity and will have no legal or constructive obligation to pay further amounts. Obligations for contributions to defined contribution plans are recognised as a personnel expense in profit or loss when they are due.

(ii) Other long term employee benefits

The Company's net obligation in respect of long term employee benefits is the amount of future benefit that employees have earned in return for their service in the current and prior periods plus related on costs.

(f) Employee benefits

(iii) Short term benefits

Liabilities for employee benefits for wages, salaries, annual leave and sick leave represent present obligations resulting from employees' services provided to reporting date and are calculated at undiscounted amounts based on remuneration wage and salary rates that the Company expects to pay as at reporting date including related on costs, such as workers compensation insurance and payroll tax.

(g) Provisions

A provision is recognised if, as a result of a past event, the Company has a present legal or constructive obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation. Provisions are determined by discounting the expected future cash flows at a pre tax rate that reflects current market assessments of the time value of money and the risks specific to the liability.

(h) Revenue

(i) Memberships, match day tickets and grants

Revenue from memberships, match day tickets and grants is measured at fair value and taken to income in the period to which it

(ii) Sponsorships

Revenue from sponsorship is measured at the present value on a straight line basis over the life of the contract.

(iii) Interest income

Interest income is recognised in the profit or loss as it accrues using the effective interest method.

(i) Finance income

Finance income comprises interest income on funds invested (included available-for-sale financial assets) and gains on the disposal of available for sale financial assets. Interest income is recognised as it accrues in profit or loss, using the effective interest method.

(j) Income tax

The company is exempt from income tax in accordance with the provisions of section 23(g) of the Income Tax Assessment Act.

(k) Parent entity financial information

The financial information for the parent entity, NSW Waratahs Limited, disclosed in note 13 has been prepared on the same basis as the consolidated financial statements, except as set out below:

(i) Investments in subsidiaries

Investments in subsidiaries are accounted for at cost in the financial statements of NSW Waratahs Limited. Dividends received from associates are recognised in the parent entity's profit or loss, rather than being deducted from the carrying amount of these investments.

(ii) Financial guarantees

Where the parent entity has provided financial guarantees in relation to loans and payables of subsidiaries for no compensation, the fair values of these guarantees are accounted for as contributions and recognised as part of the cost of the investment.

(I) Goods and services tax

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the taxation authority. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated with the amount of GST included. The net amount of GST recoverable from, or payable to, the ATO is included as a current asset or liability in the balance sheet.

Cash flows are included in the statement of cash flows on a gross basis. The GST components of cash flows arising from investing and financing activities which are recoverable from, or payable to, the ATO are classified as operating cash flows.

Income is deferred on the balance sheet until it has been earned, at which point the deferred income is recognised as income.
