

# Rugby VIC Event Refund Policy

#### 1. PURPOSE

This policy outlines the terms and conditions under which a team may request a refund for payments made via Rugby Xplorer. It includes the process to request a refund, circumstances under which a refund will be granted, and the timeline for processing approved refunds in accordance with the event dates.

## 2. SCOPE

This policy applies exclusively to refunds for Rugby VIC (RV) event entry fees. Refunds for fees charged by RV-affiliated clubs or Rugby Australia (RA) Insurance are subject to the policies of the respective clubs or RA

#### 3. REFUND ELIGIBILITY CRITERIA

RV will provide a refund under the following circumstances:

- **3.1 Cancelled Event** In the event that the competition is cancelled, or there are insufficient teams to fulfil a pool/division age group, a full refund will be issued.
- **3.2 Team Withdrawal Teams** may be eligible for a refund if they withdraw from the event within the following specified periods
  - Before Registration Closes: 50% Refund
  - After Registration Closes: 0% Refund

# 4.1 Melbourne 7's

- Location: Casey Fields, Cranbourne
- Event Dates: Sat October 11 (Seniors) and Sun October 12 (Juniors)
  - Team Entry Fee:
    - Seniors: \$485.00 (including Insurance)
    - Juniors: \$375.00 (including Insurance)
- Registration Deadline: Friday October 3

- Before October 3: 50% Refund
- After October 3: 0% Refund

• Registration Deadline: Friday October 17

After October 17: 0% Refund

# **5. REFUND REQUEST PROCESS**

To request a refund, teams must submit a written request via Rugby Xplorer or through the official RV contact channels. Refund request must be made by the specified deadlines outlined in Section 4.

## 6. REFUND PROCESSING TIMELINE

Once a refund request is approved, RV will process the refund in line with event timelines, ensuring that funds are returned within a reasonable period before or after the event date.

# 7. ADDITIONAL INFORMATION

RV is only authorized to refund entry fees charged by RV. Refunds for other fees (such as club-specific fees or RA insurance fees) are subject to the respective policies of the club or RA.
