



USA Rugby – Men’s 7s Preliminary Notice to the Athlete Selection Procedures for the 2027 Pan American Games June 25, 2026

To provide information in a timely manner, USA Rugby is releasing this Preliminary Notice to the Athlete Selection Procedures for the 2027 Pan American Games (Games). This document is being written as a complement to, and not a substitute for the Athlete Selection Procedures for the Games. Additional communication will be released by USA Rugby once the Athlete Selection Procedures for the Men’s Team have been finalized and approved by the USOPC.

A. Anticipated Athlete Eligibility Criteria:

- Athletes must comply with all Panam Sports and Pan American Rugby Confederation eligibility requirements which will be posted [here](#) once available.
- Athletes must be a national of the United States and hold a valid U.S. passport that will not expire for six months after the conclusion of the Games.
- Athletes must adhere to all USA Rugby, USADA, USOPC, WADA, World Rugby and Panam Sports anti-doping protocols, policies, and procedures including participation in Out-of-Competition Testing, if applicable.
- Athletes must comply with the [USOPC Background Check Policy](#) and [USOPC Athlete Safety Policy](#).

B. Anticipated Evaluation Events:

USA Rugby does not intend to use a formal try-out to facilitate the athlete nomination process for the 2027 Pan American Games Team (Team). It is anticipated that athletes being considered for nomination to the Team will be evaluated on their performance at the events listed below from 2025 until the date of Team nomination for the Games.

- USA Rugby Men’s 7s Residency Program (Chula Vista Athlete Elite Training Center)
- USA Rugby Men’s High Performance 7s Camps
- Men’s World Series Events or other World Rugby sanctioned international competitions

**Please note that the location, schedule, and duration of future USA Rugby events and international events will be announced at least thirty (30) days prior to the start of training or competition.*

As a team sport, a variety of criteria, both objective and subjective, will be used to nominate eligible athletes to the Team. More information will be included in the Athlete Selection Procedures for the 2027 Pan American Games.

C. Anticipated Qualification Pathway:



Athletes may qualify for the Evaluative Events listed in Section B by:

- Athlete performance in any of the following events:
 - 2025-2027 USA Rugby Talent Camps
 - 2025-2027 USA Rugby Club Championships (15s & 7s)
 - 2025-2027 USA Rugby Men's 15s International Tests
 - 2025-2027 Major League Rugby competitions
 - 2025-2027 College Rugby Championships (CRCs)
 - 2025-2027 M15 U20 World Rugby World Championships Competition and Camps
 - 2025-2027 High School 7s and 15s Rugby games, including play-offs and championships

The information in this notice is provided to assist athletes with their training and competition planning and is subject to change upon approval of the USA Rugby Selection Procedures for the 2027 Pan American Games.
