Junior State Rugby 7s – Selection Process & Protocol

October 2025

1. Purpose and Principles

The selection policy ensures a transparent, consistent, and merit-based process for identifying players to participate in the Junior State Rugby 7s competitions.

Key principles:

- Equity and fairness across regions and schools
- Player development focus recognising potential and pathway alignment
- Respect and integrity in behaviour and communication
- Selector independence decisions based on evidence and performance

2. Eligibility

To be eligible for selection, a player must:

- Be registered with an affiliated Rugby Union club or entity within the state as per the Rugby Australia Registration Regulations.
- Meet the club or entity eligibility requirements for selection in their region or association.
- Meet the age requirements as defined by Competition Rules.
- Have paid the NPIL and NPRF/MUPRF obligations (RA/QRU) as well as any region-specific competition fee or representative fee.
- Be financially and disciplinarily compliant with their club, school, and state union.

3. Nomination and Trial Registration

Regions or associations must have one of the following processes:

- a) Nomination and selection from local association competition.
- b) Nomination and selection from a trial and evaluation Process.
 - Trial Structure should involve skill, fitness, and game-based activities.
 - Evaluation Criteria should include:
 - o Technical Skills
 - Tactical Understanding
 - Athletic Qualities
 - Attitude & Coachability

4. Selection Committee

Regions or associations must advise the composition of their selection panel:

- Examples of panel members may include:
 - Program Head Coach (Chair)
 - Assistant Coach or Regional Development Officer
 - Independent Selector (not coaching the team)
 - o Talent ID / Pathway Representative (observer or advisor role)

All selectors must have appropriate accreditation and must declare any conflicts of interest.

5. Selection Outcomes

Teams will generally include 13 players + 3 non-travelling shadow reserves. Selection decisions will be made collectively and recorded in official minutes.

Announcement process:

- Teams listed on the official website or emailed directly.
- Selected players must confirm acceptance.
- Failure to confirm within the timeframe may result in replacement by a reserve.

Selection Documentation

- Documentation must clearly demonstrate selection. This must be clearly identified as being sent from, or published by, the event selector or event organiser, showing:
 - o confirmation that the athlete, coach or official has been selected to the team/role.
 - o event details such as event name, start date of the event and location of the event.

- All players, selectors, and coaches must uphold the Rugby Australia Code of Conduct.
- Breaches may result in removal from the squad or future ineligibility.
